

PRAGUE, BUDAPEST, BUCHAREST UNNUMBERED FOLLOWING IS VERBATIM EXCHANGE BETWEEN EAST BERLIN CORRESPONDENT AND CHANCELLOR ON RFE AT CHANCELLOR'S REGULAR PRESS CONFERENCE

QUESTION: SINCE THE BEG!NNING OF NOVEMBER THE FOREIGN OFFICE HAS BEEN EXAMINING, BASED ON PRESS REPORTS IN WEST GERMAN PAPERS, THE HUNGARIAN TAPE RECORDS OF RADIO FREE EUROPE. AT FIRST, A FINAL ANSWER WAS SAID TO BE FORTHCOMING IN SOME THREE WEEKS; SINCE THAT TIME, THIS PROMISE WAS "PROLONGED" AGAIN AND AGAIN. DO THE AGREEMENTS WITH THE UNITED STATES REGARDING THE GRANTING OF THE LICENSE MAKE IT NECESSARY TO REFRAIN FROM MAKING A STATEMENT OR MAY SUCH A STATEMENT STILL BE EXPECTED, AND WHAT IS YOUR PERSONAL OPINION ON WHAT BECAME KNOWN OF THE CONTENT OF THESE BROADCASTS?

THIS QUESTION I DON'T UNDERSTAND, THE LAST QUESTION .. ANSWER: TO THE OTHER QUESTIONS I CAN MAKE THIS REPLY: NO AGREEMENTS WITH THE UNITED STATES REGARDING THE GRANTING OF THE LICENSE FORCE US TO REFRAIN FROM MAKING A STATEMENT. AN EXAMINATION HAS TAKEN PLACE; THIS EXAMINATION SHOWED THAT THE ASSERTIONS WHICH HAD BEEN VOICED IN THE PRESS, THAT THE EUROPEAN RADIO STATION, OR RATHER RADIO FREE EUROPE, HAD PROMISED THE HUNGARIANS MILITARY AID FROM THE WEST, ARE NOT IN CONFORMITY WITH THE FACTS. HOWEVER, ALSO SOME REMARKS WERE MADE WHICH MIGHT GIVE RISE TO MISINTER-PRETATIONS; ON THIS, A DISCUSSION, AN EXCHANGE OF IDEAS TOOK PLACE; CHANGES IN THE STAFFING RESULTED FROM IT, AND I BELIEVE THAT FOR THE TIME BEING THE MATTER MAY BE REGARDED AS SETTLED.

IS THE RIGHT OF ASYLUM BEING VIOLATED BY THESE BROADCASTS?
