Note by the Secretary-General

Pursuant to rule 15 of the rules of procedure, the Secretary-General has the honour to propose the inclusion in the agenda of the twenty-fourth regular session of the General Assembly of an item entitled:

"Question of Korea: report of the United Nations Commission  
for the Unification and Rehabilitation of Korea".

In accordance with rule 20 of the rules of procedure, an explanatory memorandum is attached.

## EXPLANATORY MEMORANDUM

1. In accordance with paragraph 5 of General Assembly resolution 2466 (XXIII) of 20 December 1968, the United Nations Commission for the Unification and Rehabilitation of Korea, on 19 April 1969, submitted to the Secretary-General a report covering the period from 25 August 1968 to 19 April 1969. The Secretary-General transmitted that report to the Members of the General Assembly, for their information, on 14 May 1969 (A/7553).
2. The Secretary-General has now received from the Commission a further report, covering the period from 20 April to 6 September 1969, addressed to the General Assembly. The letter of transmittal, signed by the Chairman of the Commission, reads as follows:

"I have the honour to transmit the report of the United Nations Commission for the Unification and Rehabilitation of Korea to the General Assembly, in accordance with paragraph 5 of General Assembly resolution 2466 (XXIII) of 20 December 1968, covering the period since 20 April 1969 for consideration by the General Assembly at its twenty-fourth session as an important and urgent matter within the meaning of rule 15 of the rules of procedure of the General Assembly and in connexion with its consideration of other items pertaining to Korea."
