WITHDRAWAL OF UNITED STATES AND ALL OTHER FOREIGN  
FORCES OCCUPYING SOUTH KOREA UNDER THE FLAG OF

I have the honour to inform you that in conformity with its declared policy relating to all forms of military occupation and foreign military bases, the Government of the United Republic of Tanzania wishes to endorse the request made by several States for the inclusion in the provisional agenda of the twenty-fourth session of the General Assembly as a separate item the question entitled :-

"Withdrawal of United States and all other foreign forces occupying South Korea under the flag of the United Nations."
